WHEREAS, Cook County's Real Property Assessment Classification Ordinance (the "Classification Ordinance") provides for the classification of real properties located in Cook County, Illinois for real estate tax assessment purposes; and

WHEREAS, the Classification Ordinance allows for a classification known as Class 8 (the "Class 8 Designation") for commercial or industrial property within areas designated by the Cook County Assessor conditioned upon certain findings and approvals of the municipality governing the property; and

WHEREAS, the Classification Ordinance allows for a classification known as Class 8 (the "Class 8 Designation") for commercial or industrial property within townships targeted by the South Suburban Tax Reactivation Program (the "Program"), conditioned upon certain findings and approvals of the municipality governing the property; and

WHEREAS, the development of the project (the "Development Project") in the Village of Sauk Village, Cook County, Illinois (the "Village") originally qualified for and was granted the Class 8 Designation because it was intended to be a commercial development located within the corporate limits of the Village, and the Village is located in Bloom Township one, of the targeted townships as designated by the Program; and

WHEREAS, the Class 8 Designation resulted in a substantial reduction of the real estate taxes levied against such commercial or industrial property by reducing the assessment level for the property to 10 percent of market value for the initial 10 years after the development is completed, 20 percent of market value for the 11th year after completion and 25 percent of market value for the 12th year after completion; and

WHEREAS, the Village's Mayor and Board of Trustees (collectively, the "Corporate Authorities") find that the development of the Development Project continues to provide a great benefit the Village by, among other things, increasing the real estate tax base of the Village, providing job opportunities for Village residents and, the fact that the Development Project is a commercial enterprise, it continues to generate retailers' occupation tax revenues to the Village; and

WHEREAS, the Corporate Authorities find that but for the Village's consent to and support the **renewal** application of the Class 8 Designation for the Development Project, the Development Project would not be able to continue operations in the same beneficial and successful manner in the Village causing an economic hardship to both the Project and the Village; and

WHEREAS, it is therefore in the best interests of the Village to support, approve of and consent to the **renewal** of the Class 8 Designation of the Development Project;

NOW THEREFORE BE IT ORDAINED, by the Mayor and the Board of Trustees of the Village of Sauk Village, Cook County, Illinois, as follows:

SECTION 1: The statements set forth in the preamble to this Ordinance are true and correct and are adopted as part of this Ordinance.

SECTION 2: The Village finds that the development of the Project (as depicted on the Map attached hereto as Exhibit A and incorporated herein by reference) upon the property legally described on Exhibit B, attached hereto and incorporated herein by reference, is consistent with the overall plan for rehabilitation of the Village. The Village supports, approves of and consents to the **renewal** Class 8 Designation for the Development Project.

SECTION 3: The Village's Mayor is authorized and directed to execute any documents and take any other action necessary to implement the provisions of and intent of this Ordinance. The Village Clerk is authorized and directed to attest to the Mayor's signature on such documents, as necessary.



WHEREAS, the Class 8 Designation results in a substantial reduction of the real estate taxes levied against such commercial or industrial property by reducing the assessment level for the property to 10 percent of market value for the initial 10 years after the development is completed, 20 percent of market value for the 11th year after completion and 25 percent of market value for the 12th year after completion; and

WHEREAS, the Village's Mayor and Village Trustees (collectively, the "Corporate Authorities") find that the development of the Winpak Development Expansion Project will benefit the Village by, among other things, increasing the real estate tax base of the Village, providing job opportunities for Village residents and, to the extent that the Development Project includes a commercial component, it would increase the retailers' occupation tax revenues generated to the Village; and

WHEREAS, the Corporate Authorities find that but for the Village's consent to and support of the Class 8 Designation for the Development Project, the Development Project would not be economically feasible and, therefore, that the Development Project would not occur; and

WHEREAS, it is therefore in the best interests of the Village to support, approve of and consent to the Class 8 Designation of the Development Project;

WHEREAS, the Village of Sauk Village, Cook and Will Counties, Illinois (the *"Village"*) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Mayor and Board of Trustees of the Village of Sauk Village (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of the Village when it is determined to be in the best interests of the Village; and

WHEREAS, the Corporate Authorities find that it is in the best interests of the health, safety and welfare of its citizenry to amend the text of the Municipal Code of the Village to amending the Village Code provisions regarding the fee schedule for business licenses as further provided below.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION 1. That the above recitals are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.

SECTION 2: Subsection 18-29(b) of Section 18-29 (Fee Schedule), Division 1 (Generally), Article II (Business Licenses and Standards) of Chapter 18 (Business and Business

Regulations) of the Village Code is amended by adding the underlined language and removing the stricken language:

(b) With respect to business licenses, the license fee shall include one health inspection and one fire inspection. The license fee shall not include any health reinspections thereafter and there shall be a charge of \$100.00 \$60.00 for each health reinspection. There shall be no charge for the first fire reinspection if all deficiencies found in the initial fire inspection have been corrected before the first fire reinspection. If all deficiencies found in the initial fire inspection have not been corrected before the first fire reinspection, there shall be a charge of \$10.00 for the first fire reinspection, there shall be a charge of \$10.00 for the first fire reinspection, so the second fire reinspection and \$30.00 for the third and each succeeding fire reinspection.

SECTION 3: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 4: All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

ORDINANCE NO. 16-004

AN ORDINANCE AMENDING SECTION 78-218 (ESTABLISHMENT OF SERVICE) AND SECTION 78-222 (RECONNECTION OF SERVICE) TO ARTICLE IV OF CHAPTER 78 OF THE VILLAGE CODE

WHEREAS, the Village of Sauk Village, Cook and Will Counties, Illinois (the *"Village"*) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Mayor and Board of Trustees of the Village of Sauk Village (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of the Village when it is determined to be in the best interests of the Village; and

WHEREAS, the Corporate Authorities find that it is in the best interests of the health, safety and welfare of its citizenry to amend the text of the Municipal Code of the Village to amending the Village Code provisions regarding establishment of water service and reconnection of water service as further provided below.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION 1. That the above recitals are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.

SECTION 2: Section 78-218 (Establishment of Service) of Article IV of Chapter 78 of the Village Code is amended by adding the underlined language and removing the stricken language:

Sec. 78-218. - Establishment of service.

(a) Prior to the establishment of service, all outstanding bills for use of the waterworks and sewerage system at the service address must be paid in full. No new service or change in service shall be established unless all such outstanding bills have been paid.

(b) A \$75.00 deposit is required for all new accounts, and must be paid prior to the establishment of service. This deposit will be retained until the customer requests termination of service, at which time it will be applied to the customer's final bill. Any amount of this deposit not required to satisfy the final bill will be refunded to the customer. The deposit will not accrue interest.

(c) A \$10.00 \$25.00 nonrefundable fee will be charged on all new accounts to cover the administrative costs of establishing a new account.

(d) The owner, including bank owners, of any property receiving water provided through the village's waterworks system or sewer service provided through the village's sewerage system, the occupant of that property and the user of the water or sewer service provided to that property are jointly and severally is liable to pay for charges for the provision of water or sewer service to that property. Water or sewer service is furnished to any property in the village only upon the condition of this joint and several liability.

SECTION 3: Section 78-222 (Reconnection of Service) of Article IV of Chapter 78 of the Village Code is amended by adding the underlined language and removing the stricken language:

Sec. 78-222. - Reconnection of service during business hours of the Village.

(a) Service will not be reconnected until any delinquent bill for a service address is paid in full, or the payment plan for the service address is brought current.

(b) A \$25.00 \$50.00 reconnection charge must shall be paid prior to reconnection of service.

(c) If a customer requests a reconnection between the hours of 3:30 p.m. and 5:00 p.m. on business days, then service will be reconnected upon payment of all applicable fees and charges, including delinquent amounts, and the reconnection charge described in this section shall be \$75.00.

SECTION 4: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 5: All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

WHEREAS, the Mayor and Board of Trustees of the Village of Sauk Village (the "Corporate Authorities") may from time to time amend the text of the Municipal Code of the Village when it is determined to be in the best interests of the Village; and

WHEREAS, the Corporate Authorities find that it is in the best interests of the health, safety and welfare of its citizenry to amend the text of the Municipal Code of the Village to provide additional guidance regarding the rules of procedure and rules and regulations concerning motions and questions during Village Board meetings.

(i) Conduct Of Members During Debate: While a member is speaking, no member shall hold

any private discourse.

SECTION 3: If any section, paragraph, clause or provision of this ordinance shall be

held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 4: All ordinances in conflict herewith are hereby repealed to the extent of

such conflict.

SECTION 5: This ordinance shall be in full force and effect from and after its passage,

WHEREAS, the President and Board of Commissioners of the County of Cook have enacted an ordinance known as the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "*Classification Ordinance*"), which provides for a tax assessment incentive classification designed to encourage development throughout Cook County by offering a real estate tax incentive for the development of new facilities, the rehabilitation of existing structures and the utilization of abandoned buildings in order to create employment opportunities and expand the tax base; and

WHEREAS, Icon Pac Owner Pool 2, LLC (the "*Owner*") owns a certain parcel of property within the Village commonly known as 21701 S. Mark Collins Dr., Sauk Village, Illinois, identified by the permanent index number (PIN) 32-26-201-005-0000 and hereinafter legally described on Exhibit A, a copy of which is attached hereto and made a part hereof (the "*Property*"); and

WHEREAS, Owner has requested that the Mayor and Board of Trustees of the Village of Sauk Village (the "*Corporate Authorities*") support and consent to the renewal of its Cook County Class 8 Real Estate Tax Assessment Classification for the Property, as said term is defined in the Classification Ordinance (the "*Class 8 Tax Assessment Classification*"), and as previously authorized by the Corporate Authorities on November 23, 2004 by Ordinance No. 04-42, a copy of said authorizing document is attached hereto and made a part hereof, as <u>Exhibit B</u>;

WHEREAS, the adoption of an ordinance by the Corporate Authorities is required and must be filed by Owner with its renewal application with the County of Cook in order for the Property to maintain its Class 8 Tax Assessment Classification; and

WHEREAS, Owner is an important entity in the Village whose economic viability is dependent on the continued Class 8 Tax Assessment Classification; and

WHEREAS, to ensure the ongoing viability of the facility, the continuation of numerous employment positions in the Village and to safeguard the tax base of the Village, the Corporate Authorities have determined that it is necessary and in the best interests of the Village to approve the renewal of the Class 8 Real Estate Tax Assessment Classification for the Property.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Corporate Authorities find that the continuing economic viability of the Property is necessary and appropriate for the community and that without a Class 8 Tax Assessment Classification the Property would be underutilized and cause blight in the area surrounding the Property.

Section 3. The Corporate Authorities find that the Class 8 Tax Assessment Classification incentive program established by the County of Cook is necessary for the ongoing commercial use and habitability of the Property, which is the subject of this Ordinance.

Section 4. The Corporate Authorities support and consent to the filing of a Class 8 Tax

and

Incentive Eligibility Renewal Application by the Applicant and Owner of the Property, which is legally described on Exhibit A.

Section 5. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

WHEREAS, Section 2-80 of the Sauk Village Municipal Code (the "Village Code") currently sets forth the procedure by which members of the public may address the Corporate Authorities during the Board Meetings; and

WHEREAS, among the purposes of the Board Meetings is conducting Village business, which includes, without limitation, reviewing proposed agreements, personnel matters and addressing matters on on-going concern in the community; and

WHEREAS, the Corporate Authorities wish to balance the desire of the residents to participate in Board and Committee Meetings through public comment with the necessity of conducting the Village's business in an orderly and efficient manner; and

WHEREAS, based on the foregoing findings, the Corporate Authorities have determined that it is necessary and in the best interests of the Village and its residents to clarify certain provisions of the Village Code regarding public comment at Board and Committee Meetings; and

WHEREAS, based on the foregoing findings, the Corporate Authorities have determined

that it is necessary and in the best interests of the Village and its residents to amend certain

provisions of Section 2-80 of the Village Code as set forth herein;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of

the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION 1. That Section 2-80 of Division 3, Article II, of the Village Code is hereby

amended by adding the underlined language to provide as follows:

Sec. 2-80. Public Addressing board

The prior amendment to this Section is repealed. Any member of the public may address the Board once, for three minutes at the regular board meetings and committee meetings on any topic and for three minutes only on agenda items during special called meetings. Each person may give their name prior to addressing the Board. If any individual fails to yield the floor after the expiration of their allotted time, the Mayor may call for a recess or direct a Public Safety Officer to ask the individual to yield the podium.

The Public Comment portion of the meeting will not exceed 1 hour unless a majority of the board agrees to extend the time limit.

SECTION 2: This Ordinance is being amended in order to allow the public to express their opinions and questions in an orderly manner and to allow the Corporate Authorities to conduct the business of the Village in an orderly and timely manner.

SECTION 3: The Corporate Authorities may answer questions from the public in as timely a manner as possible when questions are asked at meetings or submitted in writing. The appropriate Village personnel may be consulted to answer questions to the best of their ability.

SECTION 4: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 5: All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This ordinance shall be in full force and effect from and after its passage,

approval and publication as provided by law.

(b) A \$50.00 \$100.00 reconnection charge must-shall be paid prior to reconnection of service during the Village's business hours of 8:00am to 3:30pm.

(c) If a customer requests a reconnection between the hours of 3:30 p.m. and 5:00 p.m. on business days, then service will be reconnected upon payment of all applicable fees and charges, including delinquent amounts, and the reconnection charge described in this section shall be $\frac{60.00 \pm 120.00}{50.00}$.

SECTION 3: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

SECTION 4: Any ordinance or portion of any ordinance in conflict with any provisions of this Ordinance is hereby repealed solely to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.

ORDINANCE NUMBER 16-013

AN ORDINANCE AMENDING THE VILLAGE CODE TO ADD SECTION 42-28 (PART TIME POLICE OFFICERS)

WHEREAS, the Village of Sauk Village, Cook and Will Counties, Illinois (the "*Village*") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Village of Sauk Village wishes to employ part time police officers; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/3.1-30-21, requires that municipalities employing part-time police officers shall establish hiring standards for said officers and shall submit those standards to the Illinois Law Enforcement Training and Standards Board; and

WHEREAS, the Mayor and Board of Trustees of the Village (the "Corporate

Authorities") may from time to time amend the text of Village Code when it is determined to be in the best interests of the Village; and

WHEREAS, the Corporate Authorities have determined it necessary and in the best interest of the Village to establish part-time police officer regulations as well as hiring standards for the Village in order to maintain compliance with Illinois State Statutes.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION 1. That the above recitals are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.

SECTION 2: Section 42-28 (Part Time Police Officers) is added to Article II (Police

Department) of Chapter 42 (Law Enforcement) of the Village Code to provide as follows:

SECTION 42-28. PART-TIME POLICE OFFICERS.

- A. <u>Employment</u>. The Village of Sauk Village may employ part-time police officers from time to time as they deem necessary. That for the purposes of this section, part-time police officers shall be defined as those persons hired as police officers who work less than 40 hours per week and are not appointed by the police and fire commissioners.
- B. <u>Duties</u>. A part-time police officer shall have all the responsibilities of a full-time police officer and such specific duties as delineated in the General Orders of the Village of Sauk Village Police Department, but the number of hours a part-time officer may work within a calendar year must be restricted. Part-time police officers shall not be assigned to supervise or direct full-time police officers. Part-time police officers must be trained in accordance with the Illinois Police Training Act (50 ILCS 705/1 et. seq.) and the rules and requirements of the ILETSB.
- C. <u>Hiring Standards</u>. Any person employed as a part-time police officer must meet the following standards:
 - 1. Be of good moral character, of temperate habits, of sound health, and physically and mentally able to perform assigned duties.
 - 2. Be at least twenty-one (21) years of age.
 - 3. Pass a medical examination.
 - 4. Possess a high school diploma or GED certificate.
 - 5. Possess a valid State of Illinois driver's license.
 - 6. Possess no prior felony convictions.
 - 7. Any individual who has served in the U.S. military must have been honorably discharged.
 - 8. Be a U.S. Citizen
 - 9. Be not more than 65 years of age (65 ILCS 5/10-2.1-17)
 - 10. Submit to a criminal history investigation including but not limited to fingerprints check and driving history and be free of criminal violations and major traffic offenses.
 - 11. Must show proof of passing a psychological and/or physical examination including a drug screening.
 - 12. Must have completed 400 hours of certified training as prescribed by the state law enforcement and standards board or eligible to receive a waiver of such training.
- D. <u>Discipline</u>. Part-time officers shall be under the disciplinary jurisdiction of the chief of police. Part-time police officers serve at the discretion of the chief of police or his/her designee, shall not have any property rights in said employment, and may be removed by the chief of police or his/her designee at any time. Part-time police officers shall comply with all applicable rules and General Orders issued by the Police Department. Part time police officers shall serve a probationary period for one year after the completion of in-service training.

SECTION 3: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 4: All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

AN ORDINANCE AMENDING SECTIONS 74-333 AND 74-338 OF DIVISION 2 (IMPOUNDMENT) OF ARTICLE XI (IMPOUNDMENT OF VEHICLES FOR ORDINANCE VIOLATIONS) OF CHAPTER 74 (TRAFFIC AND VEHICLES) OF THE VILLAGE CODE

WHEREAS, the Village of Sauk Village, Cook and Will Counties, Illinois, is a non-home rule municipality pursuant to the Illinois Constitution; and

WHEREAS, the Mayor and Board of Trustees have determined that the use of motor vehicles during the commission of criminal activities poses a threat to the public health, safety and welfare; and

WHEREAS, the Corporate Authorities of the Village of Sauk Village have determined that it is in the best interest of the Village and its residents that Section 74-333 and 74-338 of Division 2 (Impoundment) of Article XI (Impoundment of Vehicles for Ordinance Violations) of Chapter 74 (Traffic and Vehicles) of the Village Code regarding violations authorizing impoundment and administrative fees be amended as further set forth herein.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION ONE. Recitals. The foregoing recitals are adopted as express findings of the Corporate Authorities of the Village of Sauk Village and are incorporated herein by specific reference.

SECTION TWO. That Section 74-333 and 74-338 of Division 2 (Impoundment) of Article XI (Impoundment of Vehicles for Ordinance Violations) of Chapter 74 (Traffic and Vehicles) of the Village Code are amended to add the underlined language provide as follows:

74-333: IMPOUNDMENT OF MOTOR VEHICLES USED IN CONNECTION WITH ILLEGAL ACTIVITIES:

A. Violations Authorizing Impoundment: A motor vehicle, operated with the permission, express or implied, of the owner of record, that is used in connection with the following violations, shall be subject to tow and impoundment by the village, and the owner of record of said vehicle shall be liable to the village for an administrative fee in addition to any towing and storage fees, as hereinafter provided:

1. Operation or use of a motor vehicle in the commission or attempted commission of any offense for which a motor vehicle may be seized and forfeited pursuant to 720 Illinois Compiled Statutes 5/36-1 et seq., shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

2. Driving under the influence of alcohol, other drug or drugs, intoxicating compounds, in violation of 625 Illinois Compiled Statutes 5/11-501, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

3. Operation or use of a motor vehicle in connection with the commission or attempted commission of any felony offense in violation of the provisions of the Illinois Cannabis Control Act, 720 Illinois Compiled Statutes 550/1, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

4. Operation or use of a motor vehicle in connection with the commission or attempted commission of any offense in violation of the Illinois controlled substances act, 720 Illinois Compiled Statutes 570/100 et seq., shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

5. Operation or use of a motor vehicle in connection with the commission or attempted commission of an offense in violation of 720 Illinois Compiled Statutes 5/24-1 (unlawful use of weapons), in violation of 720 Illinois Compiled Statutes 5/24-1.5 (reckless discharge of a firearm), or in violation of 720 Illinois Compiled Statutes 5/24-3.1 (unlawful possession of firearms and firearm ammunition), shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

6. Driving while a driver's license, permit, or privilege to operate a motor vehicle is suspended or revoked pursuant to Section 6-303 of the Illinois Vehicle Code <u>or a reciprocal code</u> <u>of another state</u> shall subject the owner to an administrative fee of five hundred dollars (\$500.00); except that vehicles shall not be subjected to seizure or impoundment if the suspension is for an unpaid citation (parking or moving) or due to failure to comply with emission testing.

7. Operation or use of a motor vehicle while soliciting, possessing or attempting to solicit or possess cannabis or a controlled substance, as defined by the Cannabis Control Act or the Illinois Controlled Substances Act, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

8. Operation or use of a motor vehicle with an expired driver's license, in violation of Section 6-101 of the Illinois Vehicle Code, if the period of expiration is greater than one year, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

9. Operation or use of a motor vehicle without ever having been issued a driver's license or permit, in violation of Section 6-101 of the Illinois Vehicle Code, or operation of a motor vehicle without ever having been issued a driver's license or permit due to a person's age, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

10. Operation or use of a motor vehicle by a person against whom a warrant has been issued by a circuit clerk in Illinois for failing to answer charges that the driver violated Section 6-101, 6-303, or 11-501 of the Illinois Vehicle Code, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

11. Operation or use of a motor vehicle in the commission of or in the attempt to commit, an offense in violation of article 16 or 16A of the Criminal Code of 1961 or the Criminal Code of 2012, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

12. Operation or use of a motor vehicle in the commission of, or in the attempt to commit, any other misdemeanor or felony offense in violation of the Criminal Code of 1961 or the Criminal Code of 2012, shall subject the owner to an administrative fee of five hundred dollars (\$500.00).

74-338: Administrative Fee:

If an administrative fee is imposed pursuant to this Ordinance, such fee shall constitute a debt due and owing to the Village. If a cash bond has been posted pursuant to this Ordinance the bond shall be applied to the fee. If a vehicle has been impounded when such a fee is imposed, the Village may seek to obtain a judgment on the debt and enforce such judgment against the vehicle's owner as provided by law. Except as provided otherwise in this Section, a vehicle shall continue to be impounded until the fee is paid to the Village and any applicable towing fees and storage fees are paid to the tow company, in which case possession of the vehicle shall be given to the person who is legally entitled to possess the vehicle, or the vehicle is sold or otherwise disposed of to satisfy a judgment to enforce a lien as provided by law. If the administrative fee and other applicable fees are not paid within forty-five (45) days after an administrative fee is imposed against an owner of record who defaults by failing to appear at the hearing, the vehicle shall be deemed unclaimed and shall be disposed of in the manner provided by the Illinois Vehicle Code for the disposition of unclaimed vehicles. In all other cases, if the administrative fee and applicable fee are not paid within thirty (30) days after the expiration of time at which administrative review of the hearing officer's determination may be sought, or within thirty (30) days after an action seeking administrative review has been resolved in favor of the Village, whichever is applicable, the vehicle shall be deemed unclaimed and shall be disposed of in the manner provided by law for the disposition of unclaimed vehicles under the Illinois Vehicle Code.

Unless stayed by a court of competent jurisdiction, any fine, penalty, or administrative fee imposed under this Section which remains unpaid in whole or in part after the expiration of

the deadline for seeking judicial review under the Administrative Review Law may be enforced in the same manner as a judgment entered by a court of competent jurisdiction. <u>All monies</u> <u>collected by the village pursuant to this division shall be deposited to the Sauk Village</u> <u>Police Department Tow Fund to be used for the purposes of said fund including, but not</u> <u>limited to, police vehicle replacement and repairs, overtime pay for special unit</u> <u>deployments by the village's police department, tools and equipment for use by the</u> <u>department's narcotics and gangs units and miscellaneous expenses of the department.</u>

SECTION THREE. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

SECTION FOUR. Any ordinance or portion of any ordinance in conflict with any provisions of this Ordinance is hereby repealed solely to the extent of such conflict.

SECTION FIVE. This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.

the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION 1. That the above recitals are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.

SECTION 2: Section 74-192 (Towing Charges Regulated) of Article VII of Chapter 74 of the Village Code is amended in its entirety and replaced with the following language:

Sec. 74-192. - Towing charges regulated.

(a) Reason for towing. Before a vehicle that was towed at the direction of the department for any of the reasons set forth in the Village Code will be authorized for release to the registered owner of the vehicle, an administrative fee in the amount specified within the Village Code, or not less than \$500 if not specified, must be paid in full to the village's administrative offices during regular business hours

(b) Fees. The fees described in this section shall be exclusive of any fees imposed by the firm that actually towed the subject vehicle.

(c) Collected monies to be deposited in Sauk Village Police Department Tow Fund. All monies collected by the village pursuant to this section shall be deposited to the Sauk Village Police Department Tow Fund to be used for the purposes of said fund including, but not limited to, overtime pay for special unit deployments by the village's police department, tools and equipment for use by the department's narcotics and gangs units and miscellaneous expenses of the department. The chief of the department shall prepare an accounting of all department expenditures of funds collected pursuant to this section upon request of the village's corporate authorities or upon request of the authorized village official.

SECTION 3: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 4: All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

ORDINANCE NO. 16-016

AN ORDINANCE ADOPTING THE PREVAILING WAGE STANDARDS IN THE VILLAGE OF SAUK VILLAGE, COOK AND WILL COUNTIES, ILLINOIS

WHEREAS, the State of Illinois (the "*State*") has enacted the "Prevailing Wage Act," 820 ILCS 130/1 et seq. (the "*Act*") which is an Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works; and

WHEREAS, it is the policy of the State that a wage of no less than the general prevailing hourly rate, as paid for work of a similar character in the locality in which the work is performed, shall be paid to all laborers, mechanics and other workers employed by or on behalf of any and all public bodies engaged in public works; and

WHEREAS, the Act requires that the Village of Sauk Village investigate and ascertain the prevailing rate of wages, as defined in the Act, for laborers, mechanics and other workers in the locality of said Village of Sauk Village, employed in performing construction of public works for said Village; and

WHEREAS, the Village of Sauk Village has ascertained and examined the prevailing wage classifications and rates determined by the Department of Labor for Cook and Will Counties for July 2015, which is the last available date wage rates were published by the Department of Labor.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct

and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. To the extent and as required by the Act, the general prevailing rates of wages in the Village of Sauk Village for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Village of Sauk Village is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Cook and Will Counties areas, as determined by the Department of Labor of the State of Illinois as of the last available date wage rates were published by the Department of Labor, a copy of said determination is being attached hereto and made a part hereof as <u>Exhibit A</u>.

Section 3. As required by the Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's July prevailing rates and apply to any and all public works construction undertaken by the Village of Sauk Village and that definition of any terms appearing in the Ordinance, which are also used in the Act, shall be the same as in the Act.

Section 4. Nothing herein contained shall be construed to apply the prevailing rate of wages as herein ascertained to any work or employment except public works of the Village of Sauk Village to the extent required by the Act.

Section 5. The Village Clerk shall publicly post this determination or any revisions of such prevailing rate of wages, and keep it available for inspection at the Village Hall by any interested party. A copy of the determination or of the currently revised determination of the prevailing rate of wages then in effect shall be attached to all contract specifications.

Section 6. The Village Clerk shall mail a copy of this determination to any employer, and to any association of employees and to any person or association of employees who have filed or

file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

Section 7. The prevailing rate of wages as determined herein, or as subsequently revised, shall be included in every contract for public works, and all ordinances, resolutions, calls for bids and bid specifications relating to any public work shall state or provide that any person performing any public works on behalf of the Village of Sauk Village shall be required to pay the prevailing rate of wages to all laborers, mechanics and other workers employed for such public works. All contractors' bonds, provided by any contractor on any public works for the Village of Sauk Village shall provide a guarantee that the contractor will faithfully perform his obligations to pay the prevailing rate of wages as provided by the contractor for such projects and in accordance with the Act.

Section 8. The Village Clerk shall promptly file a certified copy of this Ordinance with the Secretary of State of Illinois, Index Department.

Section 9. The Village Clerk shall cause a notice to be published in a newspaper of general circulation within the Village and such publication shall constitute notice that the determination is effective and that said publication shall constitute notice that this is the determination of the Village and it is effective.

Section 10. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 11. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 12. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

Explanations

COOK COUNTY

The following list is considered as those days for which holiday rates of wages for work performed apply: New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Day and Veterans Day in some classifications/counties. Generally, any of these holidays which fall on a Sunday is celebrated on the following Monday. This then makes work performed on that Monday payable at the appropriate overtime rate for holiday pay. Common practice in a given local may alter certain days of celebration. If in doubt, please check with IDOL.

TRUCK DRIVERS (WEST) - That part of the county West of Barrington Road.

EXPLANATION OF CLASSES

ASBESTOS - GENERAL - removal of asbestos material/mold and hazardous materials from any place in a building, including mechanical systems where those mechanical systems are to be removed. This includes the removal of asbestos materials/mold and hazardous materials from ductwork or pipes in a building when the building is to be demolished at the time or at some close future date.

ASBESTOS - MECHANICAL - removal of asbestos material from mechanical systems, such as pipes, ducts, and boilers, where the mechanical systems are to remain.

CERAMIC TILE FINISHER

The grouting, cleaning, and polishing of all classes of tile, whether for interior or exterior purposes, all burned, glazed or unglazed

products; all composition materials, granite tiles, warning detectable tiles, cement tiles, epoxy composite materials, pavers, glass, mosaics, fiberglass, and all substitute materials, for tile made in tile-like units; all mixtures in tile like form of cement, metals, and other materials that are for and intended for use as a finished floor surface, stair treads, promenade roofs, walks, walls, ceilings, swimming pools, and all other places where tile is to form a finished interior or exterior. The mixing of all setting mortars including but not limited to thin-set mortars, epoxies, wall mud, and any other sand and cement mixtures or adhesives when used in the preparation, installation, repair, or maintenance of tile and/or similar materials. The handling and unloading of all sand, cement, lime, tile, fixtures, equipment, adhesives, or any other materials to be used in the preparation, installation, repair, or maintenance of tile and/or similar materials. Ceramic Tile Finishers shall fill all joints and voids regardless of method on all tile work, particularly and especially after installation of said tile work. Application of any and all protective coverings to all types of tile installations including, but not be limited to, all soap compounds, paper products, tapes, and all polyethylene coverings, plywood, masonite, cardboard, and any new type of products that may be used to protect tile installations, Blastrac equipment, and all floor scarifying equipment used in preparing floors to receive tile. The clean up and removal of all waste and materials. All demolition of existing tile floors and walls to be re-tiled.

COMMUNICATIONS ELECTRICIAN

Installation, operation, inspection, maintenance, repair and service of radio, television, recording, voice sound vision production and reproduction, telephone and telephone interconnect, facsimile, data apparatus, coaxial, fibre optic and wireless equipment, appliances and systems used for the transmission and reception of signals of any nature, business, domestic, commercial, education, entertainment, and residential purposes, including but not limited to, communication and telephone, electronic and sound equipment, fibre optic and data communication systems, and the performance of any task directly related to such installation or service whether at new or existing sites, such tasks to include the placing of wire and cable and electrical power conduit or other raceway work within the equipment room and pulling wire and/or cable through conduit and the installation of any incidental conduit, such that the employees covered hereby can complete any job in full.

MARBLE FINISHER

Loading and unloading trucks, distribution of all materials (all stone, sand, etc.), stocking of floors with material, performing all rigging for heavy work, the handling of all material that may be needed for the installation of such materials, building of scaffolding, polishing if needed, patching, waxing of material if damaged, pointing up, caulking, grouting and cleaning of marble, holding water on diamond or Carborundum blade or saw for setters cutting, use of tub saw or any other saw needed for preparation of material, drilling of holes for wires that anchor material set by setters, mixing up of molding plaster for installation of material, mixing up thin set for the installation of material, mixing up of sand to cement for the installation of material and such other work as may be required in helping a Marble Setter in the handling of all material in the erection or installation of interior marble, slate, travertine, art marble, serpentine, alberene stone, blue stone, granite and other stones (meaning as to stone any foreign or domestic materials as are specified and used in building interiors and exteriors and customarily known as stone in the trade), carrara, sanionyx, vitrolite and similar opaque glass and the laying of all marble tile, terrazzo tile, slate tile and precast tile, steps, risers treads, base, or any other materials that may be used as substitutes for any of the aforementioned materials and which are used on interior and exterior which are installed in a similar manner.

MATERIAL TESTER I: Hand coring and drilling for testing of materials; field inspection of uncured concrete and asphalt.

MATERIAL TESTER II: Field inspection of welds, structural steel, fireproofing, masonry, soil, facade, reinforcing steel, formwork, cured concrete, and concrete and asphalt batch plants; adjusting proportions of bituminous mixtures.

Asphalt Plant; Asphalt Spreader; Autograde; Backhoes with Caisson Attachment; Batch Plant; Benoto (requires Two Engineers); Boiler and Throttle Valve; Caisson Rigs; Central Redi-Mix Plant; Combination Back Hoe Front End-loader Machine; Compressor and Throttle Valve; Concrete Breaker (Truck Mounted); Concrete Conveyor; Concrete Conveyor (Truck Mounted); Concrete Paver Over 27E cu. ft; Concrete Paver 27E cu. ft. and Under: Concrete Placer; Concrete Placing Boom; Concrete Pump (Truck Mounted); Concrete Tower; Cranes, All; Cranes, Hammerhead; Cranes, (GCI and similar Type); Creter Crane; Spider Crane; Crusher, Stone, etc.; Derricks, All; Derricks, Traveling; Formless Curb and Gutter Machine; Grader, Elevating; Grouting Machines; Heavy Duty Self-Propelled Transporter or Prime Mover; Highlift Shovels or Front Endloader 2-1/4 yd. and over; Hoists, Elevators, outside type rack and pinion and similar machines; Hoists, One, Two and Three Drum; Hoists, Two Tugger One Floor; Hydraulic Backhoes; Hydraulic Boom Trucks; Hydro Vac (and similar equipment); Locomotives, All; Motor Patrol; Lubrication Technician; Manipulators; Pile Drivers and Skid Rig; Post Hole Digger; Pre-Stress Machine; Pump Cretes Dual Ram; Pump Cretes: Squeeze Cretes-Screw Type Pumps; Gypsum Bulker and Pump; Raised and Blind Hole Drill; Roto Mill Grinder; Scoops - Tractor Drawn; Slip-Form Paver; Straddle Buggies; Operation of Tie Back Machine; Tournapull; Tractor with Boom and Side Boom; Trenching Machines.

Class 2. Boilers; Broom, All Power Propelled; Bulldozers; Concrete Mixer (Two Bag and Over); Conveyor, Portable; Forklift Trucks; Highlift Shovels or Front Endloaders under 2-1/4 yd.; Hoists, Automatic; Hoists, Inside Elevators; Hoists, Sewer Dragging Machine; Hoists, Tugger Single Drum; Laser Screed; Rock Drill (Self-Propelled); Rock Drill (Truck Mounted); Rollers, All; Steam Generators; Tractors, All; Tractor Drawn Vibratory Roller; Winch Trucks with "A" Frame.

Class 3. Air Compressor; Combination Small Equipment Operator;

Generators; Heaters, Mechanical; Hoists, Inside Elevators (remodeling or renovation work); Hydraulic Power Units (Pile Driving, Extracting, and Drilling); Pumps, over 3" (1 to 3 not to exceed a total of 300 ft.); Low Boys; Pumps, Well Points; Welding Machines (2 through 5); Winches, 4 Small Electric Drill Winches.

Class 4. Bobcats and/or other Skid Steer Loaders; Oilers; and Brick Forklift.

Class 5. Assistant Craft Foreman.

Class 6. Gradall.

Class 7. Mechanics; Welders.

Class 1. Asphalt Plant; Asphalt Heater and Planer Combination; Asphalt Heater Scarfire; Asphalt Spreader; Autograder/GOMACO or other similar type machines: ABG Paver; Backhoes with Caisson Attachment; Ballast Regulator; Belt Loader; Caisson Rigs; Car Dumper; Central Redi-Mix Plant; Combination Backhoe Front Endloader Machine, (1 cu. yd. Backhoe Bucket or over or with attachments); Concrete Breaker (Truck Mounted); Concrete Conveyor; Concrete Paver over 27E cu. ft.; Concrete Placer; Concrete Tube Float; Cranes, all attachments; Cranes, Tower Cranes of all types: Creter Crane: Spider Crane; Crusher, Stone, etc.; Derricks, All; Derrick Boats; Derricks, Traveling; Dredges; Elevators, Outside type Rack & Pinion and Similar Machines; Formless Curb and Gutter Machine; Grader, Elevating; Grader, Motor Grader, Motor Patrol, Auto Patrol, Form Grader, Pull Grader, Subgrader; Guard Rail Post Driver Truck Mounted; Hoists, One, Two and Three Drum; Heavy Duty Self-Propelled Transporter or Prime Mover; Hydraulic Backhoes; Backhoes with shear attachments up to 40' of boom reach; Lubrication Technician; Manipulators; Mucking Machine; Pile Drivers and Skid Rig; Pre-Stress Machine; Pump Cretes Dual Ram; Rock Drill - Crawler or Skid Rig; Rock Drill - Truck Mounted; Rock/Track Tamper; Roto Mill Grinder; Slip-Form Paver; Snow Melters; Soil Test Drill Rig (Truck Mounted); Straddle Buggies; Hydraulic Telescoping Form (Tunnel); Operation of Tieback Machine; Tractor Drawn Belt Loader; Tractor Drawn Belt Loader (with attached pusher - two engineers); Tractor with Boom; Tractaire with Attachments; Traffic Barrier Transfer Machine; Trenching; Truck Mounted Concrete Pump with Boom; Raised or Blind Hole Drills (Tunnel Shaft); Underground Boring and/or Mining Machines 5 ft. in diameter and over tunnel, etc; Underground Boring and/or Mining Machines under 5 ft. in diameter; Wheel Excavator; Widener (APSCO).

TRAFFIC SAFETY

Work associated with barricades, horses and drums used to reduce lane usage on highway work, the installation and removal of temporary lane markings, and the installation and removal of temporary road signs.

TRUCK DRIVER - BUILDING, HEAVY AND HIGHWAY CONSTRUCTION - EAST & WEST

For definitions of classifications not otherwise set out, the Department generally has on file such definitions which are

If a task to be performed is not subject to one of the classifications of pay set out, the Department will upon being contacted state which neighboring county has such a classification and provide such rate, such rate being deemed to exist by reference in this document. If no neighboring county rate applies to the task, the Department shall undertake a special determination, such special determination being then deemed to have existed under this determination. If a project requires these, or any classification not listed, please contact IDOL at 217-782-1710 for wage rates or clarifications.

LANDSCAPING

Landscaping work falls under the existing classifications for laborer, operating engineer and truck driver. The work performed by landscape plantsman and landscape laborer is covered by the existing classification of laborer. The work performed by landscape operators (regardless of equipment used or its size) is covered by the classifications of operating engineer. The work performed by landscape truck drivers (regardless of size of truck driven) is covered by the classifications of truck driver.

Explanations

WILL COUNTY

The following list is considered as those days for which holiday rates of wages for work performed apply: New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Day and Veterans Day in some classifications/counties. Generally, any of these holidays which fall on a Sunday is celebrated on the following Monday. This then makes work performed on that Monday payable at the appropriate overtime rate for holiday pay. Common practice in a given local may alter certain days of celebration. If in doubt, please check with IDOL.

EXPLANATION OF CLASSES

ASBESTOS - GENERAL - removal of asbestos material/mold and hazardous materials from any place in a building, including mechanical systems where those mechanical systems are to be removed. This includes the removal of asbestos materials/mold and hazardous materials from ductwork or pipes in a building when the building is to be demolished at the time or at some close future date.

ASBESTOS - MECHANICAL - removal of asbestos material from mechanical systems, such as pipes, ducts, and boilers, where the mechanical systems are to remain.

CERAMIC TILE FINISHER

The grouting, cleaning, and polishing of all classes of tile, whether for interior or exterior purposes, all burned, glazed or unglazed products; all composition materials, granite tiles, warning detectable tiles, cement tiles, epoxy composite materials, pavers, glass, mosaics, fiberglass, and all substitute materials, for tile made in tile-like units; all mixtures in tile like form of cement, metals, and other materials that are for and intended for use as a finished floor surface, stair treads, promenade roofs, walks, walls, ceilings, swimming pools, and all other places where tile is to form a finished interior or exterior. The mixing of all setting mortars including but not limited to thin-set mortars, epoxies, wall mud, and any other

sand and cement mixtures or adhesives when used in the preparation, installation, repair, or maintenance of tile and/or similar materials. The handling and unloading of all sand, cement, lime, tile, fixtures, equipment, adhesives, or any other materials to be used in the preparation, installation, repair, or maintenance of tile and/or similar materials. Ceramic Tile Finishers shall fill all joints and voids regardless of method on all tile work, particularly and especially after installation of said tile work. Application of any and all protective coverings to all types of tile installations including, but not be limited to, all soap compounds, paper products, tapes, and all polyethylene coverings, plywood, masonite, cardboard, and any new type of products that may be used to protect tile installations, Blastrac equipment, and all floor scarifying equipment used in preparing floors to receive tile. The clean up and removal of all waste and materials. All demolition of existing tile floors and walls to be re-tiled.

COMMUNICATIONS TECHNICIAN

Installation, operation, inspection, maintenance, repair and service of radio, television, recording, voice, sound and vision production and reproduction, telephone and telephone interconnect, facsimile, equipment and appliances used for domestic, commercial, educational and entertainment purposes, pulling of wire through conduit but not the installation of conduit.

MARBLE FINISHER

Loading and unloading trucks, distribution of all materials (all stone, sand, etc.), stocking of floors with material, performing all rigging for heavy work, the handling of all material that may be needed for the installation of such materials, building of scaffolding, polishing if needed, patching, waxing of material if damaged, pointing up, caulking, grouting and cleaning of marble, holding water on diamond or Carborundum blade or saw for setters cutting, use of tub saw or any other saw needed for preparation of material, drilling of holes for wires that anchor material set by setters, mixing up of molding plaster for installation of material, mixing up thin set for the installation of material, mixing up of sand to cement for the installation of material and such other work as may be required in helping a Marble Setter in the handling of all material in the erection or installation of interior marble, slate, travertine, art marble, serpentine, alberene stone, blue stone, granite and other stones (meaning as to stone any foreign or domestic materials as are specified and used in building interiors and exteriors and customarily known as stone in the trade), carrara, sanionyx, vitrolite and similar opaque glass and the laying of all marble tile, terrazzo tile, slate tile and precast tile, steps, risers treads, base, or any other materials that may be used as substitutes for any of the aforementioned materials and which are used on interior and exterior which are installed in a similar manner.

A proposal to extend the current contract has been negotiated between the Village of Sauk Village and Republic Services for Municipal Solid Waste Collection and Transportation (the "Agreement"), a copy of which is attached hereto and made a part hereof as Exhibit A, is hereby approved substantially in the form presented to this Village Board, with such necessary changes and revisions therein determined being authorized and approved by execution and delivery of the Agreement by the Village President.

SECTION 3: The Village President and Village Clerk are hereby authorized and directed to execute and deliver the Agreement and any and all other documents necessary to implement the provisions, terms and conditions thereof, as therein described.

SECTION 4: The officers and officials of the Village are hereby authorized to undertake actions on the part of the Village as contained in the Agreement to complete satisfaction of the provisions, terms or conditions stated therein.

SECTION 5: The Village Comptroller and Village Treasurer are hereby authorized and directed to expend such necessary funds and undertake such financial action on the part of the Village as contained.

SECTION 6: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

SECTION 7: All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

SECTION 8: This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.

WHEREAS, the Village of Sauk Village, Cook County, Illinois (the "Village") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Mayor and Board of Trustees of the Village of Sauk Village (the "Corporate Authorities") may from time to time amend the text of the Village Code when it is determined to be in the best interests of the residents of the Village; and

WHEREAS, the Corporate Authorities find it in the best interests of the Village to dissolve the emergency telephone system board in the Village.

WHEREAS, the Village has established and operated an Emergency Telephone System Board ("ETSB") pursuant to Section 15.4 of the Emergency Telephone System Act (50 ILCS 750/15.4) as set forth in Title 3 (Boards and Commissions), Chapter 8 (Emergency Telephone System Board) of the Village Code of the Village of Sauk Village, as amended (the "Code"); and

WHEREAS, the Village receives statutorily authorized surcharges and the Village's ETSB expends such surcharge funds in accordance with the applicable state laws; and

WHEREAS, Section 15.4 of the Emergency Telephone System Act (50 ILCS 750/15.4), as amended by Public Act 99-006 (effective January 1, 2016), authorizes two or more municipalities that impose a surcharge pursuant to 50 ILCS 750/15.3 to establish by intergovernmental agreement a "Joint Emergency Telephone System Board" ("JETSB"), provided that the local emergency telephone system boards are terminated by ordinances that rescind their establishment, authority and operational functions; and

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq., (the "Act") authorizes units of local government to exercise jointly with any public agency of the State, including other units of local government, any power, privilege or authority which may be exercised by a unit of local government individually, and to enter into contracts for the performance of governmental services, activities or undertakings; and

WHEREAS, the Village of Calumet Park (the "Calumet Park") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, Article VII, Section 10 of the Illinois Constitution of 1970 authorizes units of local government to enter into contract to exercise, combine or transfer any power or function not prohibited by law; and

WHEREAS, the Village Board has determined that it is in the best interests of the Village to dissolve the Village's ETSB and to join the JETSB which is comprised of member entities of Calumet Park to further the Village's interests in transitioning its police emergency dispatch services to Calumet Park.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Sauk Village, Cook County, Illinois, as follows:

SECTION 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

SECTION 2: The Village's ESTB is hereby dissolved and Chapter 2, Article V, Division 4 of the Village Code of the Village of Sauk Village is repealed in its entirety and reserved, beginning on a date to be determined by the Village Administrators; and the Village Mayor, the Village Chief of Police and/or the Village Administrator are authorized to take all steps necessary, including the execution of all documents related to the Village's property dissolution of the Village's ETSB.

SECTION 3: The Village is authorized to join the JETSB, which is comprised of member entities of Calumet Park to enable the Village's transition of its emergency dispatch services to Calumet Park; and the Village Mayor, Village Chief of Police, a representative from the Village Fire Department, Village Homeland Security and the Village Administrator are authorized to take all steps necessary, including the execution of all documents related to the Village's transition of its emergency dispatch services to Calumet Park and to facilitate the Village's membership in the JETSB.

SECTION 4: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

<u>SECTION 5:</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 6: This ordinance shall be in full force and effect from and after its passage, approval by the Village Board, and publication as provided by law.

AN ORDINANCE ADOPTING AN EXPENSE REIMBURSEMENT POLICY IN ACCORDANCE WITH THE LOCAL GOVERNMENT TRAVEL EXPENSE CONTROL ACT (PUBLIC ACT 099-0604)

WHEREAS, the Village of Sauk Village, Cook and Will Counties, Illinois (the "Village"), is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, Public Act 099-0604 established the Local Government Travel Expense Control Act (the "Act"), which requires all non-home rule units of local government to adopt by resolution or ordinance a policy governing reimbursement of all travel, meal, and lodging expenses of officers and employees; and

WHEREAS, by the Mayor and Board of Trustees of the Village find it to be in the best interest of the Village to adopt a policy so that is in accordance with the Act;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois as follows:

SECTION 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

SECTION 2. That Section 2.181 ("Expense Reimbursement Policy") of Division 1 ("Generally") of Article IV ("Officials and Employees") of the Code of Sauk Village is hereby

created by adopting the following policy governing reimbursement of all travel, meal, and

lodging expenses in lieu thereof:

Sec. 2-181 Expense Reimbursement Policy

A. <u>Purpose.</u>

The Board of Trustees will reimburse employee and officer travel, meal, and lodging expenses incurred in connection with pre-approved travel, meal, and lodging expenses incurred on behalf of the Village of Sauk Village. Employees and officers are expected to exercise the same care in incurring expenses for official business as a prudent person would in spending personal funds.

B. <u>Definitions.</u>

"Entertainment" includes, but is not limited to, shows, amusements, theaters, circuses, sporting events, or any other place of public or private entertainment or amusement, unless ancillary to the purpose of the program or event.

"Travel" means any expenditure directly incident to official travel by employees and officers of the Village of Sauk Village or charges of the Village of Sauk Village involving reimbursement to travelers or direct payment to private agencies providing transportation or related services.

C. <u>Authorized Types of Official Business.</u>

Travel, meal and lodging expenses shall be reimbursed for employees and officers of the Village only for purposes of official business conducted on behalf of the Village, which includes, but is not limited to off-site or out-of-town meetings related to official business and pre-approved seminars, conferences and other educational events related to the employee's or officer's official duties.

D. <u>Maximum Allowable Expenses.</u>

<u>Maximum Expenses</u> – Travel, meal, and lodging expenses incurred by any employee or official must not exceed \$750.00 unless otherwise approved in an open meeting by a majority roll-call vote of the Board of Trustees.

<u>Airfare</u> – Travelers are expected to obtain the lowest available airfare that reasonably meets business travel needs. Travelers are encouraged to book flights at least thirty (30) days in advance to avoid premium airfare pricing. Only coach or economy tickets will be paid or reimbursed.

<u>Personal Automobiles</u> – Travelers must check to see if an agency vehicle is available before asking for approval to use their personal vehicles. Use of a personal vehicle for business must be approved prior to the use. Mileage reimbursement will be based on mileage from the work location office to the off-site location of the official business, not from the employee's or officer's residence unless said distance from the employee's or officer's residence is less than the mileage from the work location office to the off-site location. When attending a training event or other off-site official business directly from an employee's or officer's residence, no reimbursement will be made if the distance is less than the mileage of a normal commute to the workplace. An employee or officer will be reimbursed at the prevailing IRS mileage rate. The traveler will only be reimbursed up to the price of a coach airfare ticket if they drive to a location for which airfare would have been less expensive.

<u>Automobile Rentals</u> – Travelers will be reimbursed for the cost of renting an automobile including gasoline expense only as limited in this section. Travelers using rental cars to conduct official business are required to purchase insurance through the rental agency or provide proof of personal insurance equivalent to the rental agencies insurance. Car rental insurance will cover the vehicle during personal use, *e.g.*, using the vehicle after the conference has ended. Compact or mid-size cars are required for two or fewer employees or officers traveling together and a full-size vehicle may be used for three or more travelers. The traveler must refuel the vehicle before returning it to the rental company.

<u>Tolls</u> – The Village will reimburse an employee for incidental tolls associated with approved travel.

<u>Public Transportation</u> – In the case of local training or official business where an employee or officer chooses to use public transportation, reimbursement for use of public transportation will be made upon documentation of a paid receipt. When attending training or business directly from an employee's or officer's residence, no reimbursement will be made if the distance is less than the mileage of a normal commute to the workplace. If the distance is higher than the traveler's normal commute, reimbursement will be paid at the differential of the commute less the mileage of a normal commute to the workplace.

<u>Hotel/Motel Accommodations</u> – The traveler will be reimbursed for a standard singleroom at locations convenient to the business activity. In the event of a change in plans or a cancellation, the traveler must cancel the hotel/motel reservation so as not to incur cancellation charges. Cancellation charges will not be reimbursed by the Village unless approved by a vote of the Board of Trustees.

<u>Meals</u> – Receipts must substantiate the cost of the meals. If the destination city is an area of high cost, the Village Manager may approve reasonable expenditures in excess of the established rate of \$40.00 per day. No payment or reimbursement may be made for personal supplies, alcoholic beverages, or entertainment. If some meals are included in

the prepaid registration fees, the employee or officer of the Village may not be reimbursed for those meals.

<u>Vacation in Conjunction with Business Travel</u> – In cases where vacation time is added to a business trip, any cost variance in airfare, car rental, lodging and/or any other expenses must be clearly identified on the Travel, Meal, and Lodging Expense Report form and paid by the traveler.

<u>Accompanied Travel</u> – When a traveler is accompanied by others not on official business, any lodging, transportation, meals or other expenses above those incurred for the authorized traveler will not be reimbursed by the Village of Sauk Village.

<u>Parking</u> – Parking fees at a hotel/motel will be reimbursed only with a receipt.

E. <u>Approval of Expenses.</u>

Travel, meal, and lodging expenses that are in excess of the maximum \$750.00 incurred by any employee must be previously approved in an open meeting by a majority roll-call vote of the Board of Trustees.

Travel, meal, and lodging expenses incurred by any member of the Board of Trustees must be approved by roll call vote at an open meeting of the Board of Trustees.

Travel, meal, and lodging expenses advanced as a per diem to any employee or any member of the Board of Trustees must be approved by roll call vote at an open meeting of the Board of Trustees prior to payment. Documentation of expenses must be provided in accordance with Sections C, D and F of this policy, and any excess from the per diem must be repaid.

F. <u>Documentation of Expenses.</u>

Before an expense for travel, meals, or lodging may be approved under Section E of this Policy, the following minimum documentation must first be submitted, in writing, to the Board of Trustees on a Travel, Meal, and lodging Expense form:

- (1) an estimate of the cost of travel, meals, or lodging if expenses have not been incurred or a receipt of the cost of the travel, meals, or lodging if the expenses have already been incurred;
- (2) the name of the individual who received or is requesting the travel, meal, or lodging expense;
- (3) the job title or office of the individual who received or is requesting the travel, meal, or lodging expense; and

(4) the date or dates and nature of the official business for which the travel, meal, or lodging expense was or will be expended.

All documents and information submitted under this Section are public records subject to disclosure under the Freedom of Information Act.

The Village of Sauk Village hereby adopts as its official standardized form for the submission of travel, meal, and lodging expenses the Travel, Meal, and lodging Expense Report form attached hereto.

G. <u>Entertainment Expenses.</u>

No employee or officer shall be reimbursed for any entertainment expense, unless ancillary to the purpose of the program, event or other official business.

H. <u>Exceptions.</u>

Exceptions for good cause may be granted with Village Board approval.

SECTION 3. That if any section, paragraph, clause, phrase or part of this ordinance is

for any reason held invalid, such decision shall not affect the validity of the remaining provisions

of this ordinance, and the application of these provisions to any persons or circumstances shall

not be affected thereby.

SECTION 4. All ordinances or parts of ordinances in conflict with the provisions of this

ordinance are hereby repealed insofar as they conflict herewith.

SECTION 5. That this ordinance shall be in full force and effect from and after its passage as provided by law.

SECTION 6. That this ordinance is authorized to be published in pamphlet form.
